The Trust had been performing its activities to commission an Educational College at Polur and initiating the preliminary duties to commence one such college.

Now it is resolved to supplement the following clauses as part and parcel of the Trust Deed, dated 23.12.1996.

1. The name of the Trust shall be "SRI'REMUGAMBAL EDUCATIONAL TRUST"

2. The Registered Office shall be at 37, Diversion Road, Polur and the administration office shall be at No.1 C.C. Road, Ettivadi Village & Post, Polur Tk. at where the above Institution is situated.

3. The Board of Trustees shall be the above Trustees named from 1 to 5 and among whom the 1st Trustee shall be the Managing Trustee / Chairman of the Trust, who shall work after all the affairs of the institution and day to day accounts and every administration activities of the daily affairs. All responsibilities with regards to University approvals, Central and State Government Official obligations and such other legal activity etc. shall be boked after by him.

4. The income derived from property held under trust wholly for charitable purpose will be applied to such charitable purposes in India, and if any such income is accumulated or set apart for application to such purposes in India, to the extent to which the income so accumulated or set apart shall be less than fifteen percent of the income from such property and the same shall be invested in the specified investments as per the provisions of Sec.11 of the Income Tax Act 1961. If the income is not so utilized in pursuance of Sec.11, such income will be offered for income tax purposes.


